- All payments shall be made by the TPSODL to the Contractor within 45 days from the date of receipt of Contractor's error free invoice along with all the back-up documents complete in all respects.

Revised Payment Term Clause

- Monthly running bill shall be submitted based on actual completion of work at site duly certified by the Engineer.
- 60% of running account invoice cleared within 15 days of submission of certified invoice.
- Balance 40% of running account invoice shall be cleared within 30 days from the date of receipt of contractor's error free invoice along with all the backup documents complete in all respect.
- Retention: 5% of the gross value of each Running account (RA) shall be retained as retention money. This retention money shall be released after satisfactory completion of defect liability period.
