Commercial Qualification Criteria

- I. The bidder should have average annual turnover of Rs. **5 Crores** in any of the three financial years from (FY 19-20, FY 20-21, FY 21-22 and FY 22-23). Audited balance sheet, profit and loss account and auditors report from the statutory auditors of the company required).
- II. Bidder should not have been blacklisted by any Govt. Organization / utility. Bidder shall submit self-undertaking in this regard.
- III. The prospective Bidder(s) should be a registered Sole Proprietor Firm / Partnership Firm/ Company and should possess all Statutory Compliance like Valid PAN, ESI registration, EPF registration, GSTN Registration etc. Bidder must submit the copy of all these Registration certificates.
- IV. Each bidder shall submit bid by himself only. A bidder in joint venture/ consortium shall not be allowed to participate in the Tender. Bidder must submit the self-undertaking along with bid.
