- 6. M/S Sudhir Kumar Sabat was disqualified in Safety, QR and TER due to non-submission of work order, performance certificate, inadequate experience and non-submission requisite safety documents.
- 7. **M/S Maa Chamunda Enterprises** was disqualified in QR due to non-submission of work order, performance certificate, PF and ESI.
- 8. **M/S Manasi Panda** was disqualified in Safety, QR and TER due to non-submission of work order, performance certificate, inadequate experience and non-submission requisite safety documents.
- 9. **M/S Neha Décor** was disqualified in QR due to non-submission GSTIN amount to government.
- **10. M/S Rama Krishna Patnaik** was disqualified in QR due to non-submission active GSTIN.
